PRE-STATE CHAMPIONSHIPS

- 1. CHAMPIONSHIP QUALIFICATIONS (from 2024 OSAA Golf Plan)
 - D. <u>4A/3A/2A/1A Girls</u>: Note: Allocations listed below subject to change due to the number of teams / individuals competing at special district tournaments.
 - Team Automatic Qualifiers: The top allocated number of teams from the special district tournament. Special District 1 4; Special District 2 2; Special District 3 4; Special District 4 2.
 - 2) Individual Automatic Qualifiers: The top 5 individuals from each Special District must be in the Top 5 overall to qualify for the State Championships.
 - 1) **Ties**: Any ties for final team or individual qualification spots shall be broken by the Special District prior to submitting the official state championship entry to the OSAA.

2. PRE-STATE CHAMPIONSHIP POSTING TIMELINE:

Tee times for team and individual qualifiers will be posted on the OSAA website by 6pm on Wednesday, May 8.

- B. District Meet Directors AND coaches of qualifying teams and individuals are responsible for checking the accuracy of the entry information. Please check your entries for correct spelling of participant's name, year in school, and school name, as this information *will appear the same way on the digital scorecards, score sheets, and in the championship results unless corrected.*
- 3. <u>CORRECTIONS DEADLINE</u>: Thursday, May 9, by Noon. CONTACT Missy Smith at 503.682.6722 x227 (office); toll free at 1.888.838.6722, 503.709.4867 (cell) or via email at <u>missys@osaa.org</u>. This information *will appear the same way on the digital scorecards, score sheets, and in the championship results unless corrected*.
- 4. <u>STATE CHAMPIONSHIPS INDIVIDUAL SPORT SUBSTITUTIONS</u> (OSAA Handbook, Executive Board Policies)
 - A. The following shall be the policy for substitutions in individual sport State Championship events. All individuals who are substitutes for individual qualifiers must have participated in a District or Special District Meet.
 - 1) Individuals:
 - a) <u>6A and 5A Boys and Girls</u>: If an individual qualifier drops out of the state championship by 4pm two business days prior **(Thursday, May 9)** to the state championship, the district or regional (depending on how the individual originally qualified) may substitute the next eligible individual qualifier not a member of a qualifying team. The district must notify the OSAA office of any such substitution by 4pm two business days prior **(Thursday, May 9)** to the state championship.
 - b) <u>4A Boys, 4A/3A/2A/1A Girls, 3A/2A/1A Boys</u>: Substitutions for individual qualifiers not members of qualifying team are not permitted.
 - 2) **Team**: Substitutions on qualified teams may be made up to one hour prior to the start of each round of the state championship. A team may enter a maximum of five participants with its top four finishers counting toward team standings.

Notification - Schools are required to notify the OSAA prior to the start of a state championship event if a student entered in the event will be unable to compete for any reason. Failure by a school to notify the OSAA prior to the start of a state championship event may result in a fine and /or other penalty being assessed to that school. **The district must notify the OSAA office, Missy Smith at 503.682.6722 x227 (office); toll free at 1.888.838.6722, 503.709.4867 (cell)**.

5. <u>WITHDRAWAL FROM STATE CHAMPIONSHIPS</u> (OSAA Handbook, Executive Board Policies) (Revised Fall 2008)

By entering participants in a state championship meet, contest or tournament, each member school certifies that, barring injury, illness or unforeseen events, or a withdrawal to avoid violating the religious convictions of team members, the team or individuals representing the school will participate in every game or competition, that is part of that championship event, until the final conclusion of the meet, contest or championship. Any withdrawal or intentional forfeiture for reasons other than those specified shall be considered a sportsmanship violation, and shall be subject to reprimand and/or other penalties as determined by the Executive Board. See Executive Board Policies, "Withdrawal During a Competition" for more information.

STATE CHAMPIONSHIPS

1. CHAMPIONSHIP FORMAT:

- A. The State Championship will be a two-day 36-hole event. Play will commence each day at 10am.
- B. <u>Team Competition</u>: A school entering a team of four or five players will be competing for the team championship. A school with less than four scores will not be considered a part of the team competition. Team scores shall be determined by adding a team's four best individual scores on the first day of play to a team's four best individual scores on the second day of play. In the event of a tie for first place at the end of the second round, the team with the lower 5th score from Tuesday's round will be declared the champion. If the teams are still tied at that point, the team with the lower 5th score from Monday's round will be declared the champion. If the teams are still tied, the teams will be declared co-champions. Ties for places other than first will not be broken.
- C. <u>Individual Competition</u>: All players in the State Championship may compete for individual honors. Ties for individual honors will not be broken.
- 2. <u>PAIRINGS / TEE TIMES</u>: First round pairings / tee times will be posted on iWanamaker by 6pm on Wednesday, May 8. Second round pairings / tee times will be posted on iWanamaker following play on Monday. Pairings for the second round will be based on first round scores with Monday's team leaders going off the #1 tee last. All 4A/3A/2A/1A Girls tee times for both days will start at 10am.
- 3. <u>COACHES' MEETING</u>: There will be a coaches' meeting at 7pm on Sunday, May 12, in the Snack Bar adjacent to the Pro Shop and all coaches are encouraged to attend.
- 4. <u>PRACTICE ROUNDS</u>: NOTE: Coaches will not be allowed to play during the practice rounds as there are only enough times to accommodate participating players. The OSAA has organized a block of tee times between Noon and 2:20pm for teams to access the golf course for a practice round. Teams will play in fivesomes during the allotted times and coaches can purchase the use of a golf cart to tour the course with their players for \$20. If a school wishes to schedule a tee time outside of the organized block, they will have to play in foursomes. Participants will each be charged \$5 for this practice round on Sunday. Range balls will be available for purchase on Sunday during practice rounds. Cost is \$4 per token (30 balls per token). Qualifying teams and individuals are allowed to play additional practice rounds at Tokatee Golf Course prior to the State Championship. Contact Tokatee Golf Course for rates and availability.
- 5. <u>FROST DELAY PROCEDURE</u>: Please contact Tokatee Golf Club (541.822.3220) beginning at 8am on Monday or Tuesday if due to weather conditions a frost delay is possible.
- 6. <u>RANGE BALLS</u>: Range balls will be provided free of charge on Monday and Tuesday prior to the start of a player's round. Large buckets of range balls will be put out on the practice range at 8am each day. Only players participating in the State Championship should be using the range during this time.
- 7. <u>HOLE LOCATION SHEETS / NOTICE TO PLAYERS</u>: Each player will receive a copy of that day's hole locations along with the Notice to Players for the State Championship on their first tee on both Monday and Tuesday. (see attached OSAA Hard Card & Notice to Players for more information)
- 8. <u>SUMMER RULES</u>: Summer rules will be used at the State Championships. In the event of inclement weather/course conditions, the OSAA, in conjunction with the Rules Committee and the course professional, may authorize the Cleaning Ball Local Rule.
- 9. <u>YARDAGE / TEE MARKERS</u>: Tokatee Course has 150-yard markers on each hole. Yardage is also marked on sprinkler heads. All yardage is to the center of the green. Players will use the YELLOW tee markers during both rounds of the championship. All other tee markers will be removed to avoid confusion.
- 10. <u>SPECTATORS</u>: Spectators must stay on cart paths or in the rough and at least 30 yards from any competitor during play. At no time should a spectator be on the green, on the tee, in a fairway, in a bunker, in a hazard, nor should they stand behind a player during his/her swing. Spectators may not communicate with participants from the time a player begins his/her round until his/her scorecard is handed in. Competitors may be penalized and / or disqualified if any person, other than the designated coach, assists the competitor by coaching and / or giving advice, which could influence a player in determining play, the choice of a club or method of making a stroke. Spectators may provide a participant with food, towels, umbrellas, rain suits, etc., during a round.
- 11. <u>SCORING PROCEDURE</u>: Competitors must have the OSAA scoring app (iWanamaker) downloaded on their phone prior to teeing off. Each player should keep their own backup scorecard. Each competitor (marker) will be responsible for keeping score for another competitor in the group on the app. After each hole, the marker should check the score with the competitor and attest it.

At the conclusion of the round, the entire group shall proceed immediately to the scoring area. The marker should confirm the digital scorecard. Competitors are to review their digital scorecard thoroughly for the accuracy of the hole-by-hole score and settle any disputes with the Rules Committee. The competitor is responsible for the correctness of the digital score recorded for each hole on his digital scorecard. If they return a score for any hole lower than actually taken, they are disqualified. If they return a higher score for any hole than the score actually taken, the score as returned stands. The competitor should make sure the marker has attested / confirmed the digital scorecard at the score table. No alteration may be made on a digital scorecard after the competitor has attested / confirmed it and left the scoring area. The digital scorecard is considered to have been official when the competitor leaves the scoring area.

- 12. <u>CELL PHONES / MOBILE DEVICES</u>: The OSAA believes that appropriate and considerate use of these devices is necessary during competition.
 - A. <u>Players</u>: Players shall not take cell phones / mobile devices on the courses for use of communication. If a player uses such a device at any point during their round, they may be subject to disqualification.
 - B. <u>Coaches and Spectators</u>: Cell phones must be set to vibrate or silent mode and shall not ring at any time while on the golf course. Cell phone conversations are prohibited at all times while on the golf course. If you need to take/make a call, please proceed to the clubhouse or parking lot.
- **13.** <u>PACE OF PLAY</u>: The OSAA and the host courses are emphasizing pace of play during this year's state championships. Groups are expected to adhere to the pace of play guidelines printed on their scorecard. A group's position should be immediately behind the group in front, not immediately in front of the group behind. Groups may be affected if they are behind the scheduled pace and out of position. Out of position is defined as:
 - A. <u>**On par 3**</u> Having a clear hole ahead.
 - B. **On par 4** The group ahead replaces the flagstick before your group leaves the tee area.
 - C. **On par 5** The group ahead arrives on the green before your group leaves the tee area.

14. CARTS:

- A. <u>Motorized Carts Participants</u>: During the round, a player must not ride on any form of motorized transportation except as authorized or later approved by the Committee (a player may always ride to and from where a previous stroke was made). Penalty for breach of Local Rule is the general penalty for each hole where the breach occurred. If the breach occurred between the play of two holes, it applies to the next hole.
- B. <u>Motorized Carts Spectators</u>: Spectators, at the discretion of the golf course, may use motorized golf carts at the OSAA State Championships. Fees, rules and regulations of the use of golf carts are governed by the host golf course. Fee is \$20 per rider for spectator carts.
- C. <u>Pull Carts Participants</u>: Participants can use a pull cart in competition. Please note that there are a limited number of carts available and they are \$4 per day to rent.
- **15.** <u>RULES COMMITTEE</u>: The OSAA will have a Rules Committee at the State Championship. Rules Committee members will be on the course in clearly marked golf carts to answer questions and make rules interpretations as necessary. Committee members will have walkie-talkies in order to collaborate on rulings.
- **16.** <u>UNSPORTSMANLIKE BEHAVIOR</u>: A Rules Committee member may disqualify a player without warning for unsportsmanlike conduct such as throwing a club, disrespectfully addressing or striking an opponent or official, using profanity or obscene gestures, intentionally obstructing an opponent's line of play, etc.
 - A. Any disqualification for unsportsmanlike conduct disqualifies the player for the entire championship. Substitution of a player disqualified for unsportsmanlike conduct is not permitted.
 - B. Disqualification for a violation of USGA rules applies to that day's competition only.
- 17. <u>RESTROOMS ON COURSE</u>: Tokatee Golf Course has on-course restrooms near #7, #11 and #15. Restrooms are also available in the clubhouse and near the practice putting green.
- **18.** <u>FOOD</u>: Tokatee Golf Course has a restaurant in the clubhouse, which will open at 8:30am each day. Coaches are encouraged to order lunches for players at the start of each day to avoid having to wait in line or utilizing the phone on the 9th tee.

- **19.** <u>AWARDS</u>: All awards will be presented following the conclusion of each championship on Tuesday.
 - A. <u>**Trophies**</u> Champion through fourth place trophies will be awarded in each championship.
 - B. <u>Medals</u> Medals will be presented to the champion and second place teams in each championship. Medals will also be presented to the top ten individuals at each state championship who will be recognized as members of the OnPoint Community Credit Union All-Tournament Team.
 - C. <u>Moda Health Athlete of the Meet</u> The medalist in each classification will be recognized as that classification's Moda Health Athlete of the Meet. In the event of a tie for medalist, multiple winners will be recognized. The winners will receive a commemorative coin from Moda Health and a scholarship application.
 - D. <u>Flags</u> The Oregon Golf Course Superintendents Association (OGCSA) has generously donated logo flags for use during each of this year's state championships. Their goal is to familiarize young golfers with the OGCSA and bring awareness to their role in the game today. The logo flags will be distributed to the top finishers at each of this year's state championships.

TOKATEE GOLF CLUB—NOTICE TO PLAYERS

- 1. The USGA Rules of Golf and the OSAA Hard Card, as modified by these Local Rules, govern all play. Please disregard all Local Rules on the Tokatee Golf Club scorecard.
- 2. <u>TEEING AREA</u>: Play will be from the YELLOW tee markers.
- 3. <u>OUT OF BOUNDS (RULE 18)</u>: When two stakes are located within two yards of each other, the boundary is deemed to extend to infinity in the direction of the stakes.
- 4. <u>IMMOVABLE OBSTRUCTIONS (RULE 16)</u>: The following are defined as immovable obstructions: artificially surfaced cart paths and roads and their extensions, sprinkler heads and sprinkler control boxes. Relief from staked trees is for the stake and/or tie only. Exception: Chipped bark pathways are integral parts of the course and relief without penalty is not available. Individual pieces of bark are loose impediments.

5. GROUND UNDER REPAIR (RULE 16):

- A. Ground under repair includes all French drains and maintained flower beds.
- 6. <u>DROPPING ZONE HOLE #17</u>: During the play of hole #17, if relief is entitled from the penalty area, as an additional option to Rule 17, a ball may be dropped under one penalty stroke in the dropping zone located on the putting green side of the penalty area.
- 7. <u>PACE OF PLAY</u>: The maximum time allowed for the round is four hours and forty-five minutes. Any player exceeding the allowed time and out of position by completing a hole more than 15 minutes behind the previous group is subject to a possible penalty under Rule 5.6.
- 8. <u>SCORING:</u> Promptly upon completion of the round, all players in the group must proceed to the scoring area to resolve any Rules issues and return their scorecards. A player is responsible to make sure that the marker certifies the hole scores and must certify the hole scores themselves. No alterations may be made on the scorecard once it has been returned. A scorecard is considered returned when the player has handed the scorecard to a scoring official and has left the scoring area defined by rope or tape.
- 9. <u>TIES:</u>

<u>Team Competition</u>: In the event of a tie for first place at the end of the second round, the team with the lower 5 scores from Tuesday's round will be declared the champion. If the teams are still tied at that point, the team with the lower 5 scores from Monday's round will be declared the champion. If the teams are still tied, the teams will be declared co-champions. Ties for places other than first will not be broken.

Individual Competition: All players in the State Championships may compete for individual honors. Ties for individual honors will not be broken.

OSAA / OnPoint Community Credit Union GOLF STATE CHAMPIONSHIPS 2024 OSAA Local Rules and Terms of the Competition For Use in the State Championship and District and Regional Qualifying



The Rules of Golf as approved by the United States Golf Association and the R&A govern play and where applicable, by the following Local Rules and Terms of the Competition. Complete text of Rules and Local Rules may be found in the Official Guide to the Rules of Golf, effective January 2024. Unless otherwise noted, the penalty for breach of a Local Rule is the general penalty. See Notice to Players for additional Local Rules and Terms of the Competition. If a player in a team competition breaches a Rule that results in disqualification, the effect will be to disqualify the player for that round only. Exception: serious misconduct, in which it is up to the Committee.

<u>Please note that while in some earlier competitions this year the Local Rule for Alternative to Stroke and Distance for Ball Lost or</u> <u>Out of Bounds may have been used, the Local Rule is not in effect for any competition covered by this document.</u>

- 1. <u>OUT OF BOUNDS</u>: Defined by the line between the course-side points, at ground level, of the white stakes or fence posts. Out of bounds may also be defined by white lines.
- 2. <u>PENALTY AREAS</u>: When a penalty area is defined on only one side, it extends to infinity. When a penalty area is connected to the out of bounds edge, the penalty area extends to and coincides with out of bounds.

3. GROUND UNDER REPAIR:

- A. Defined by white lines. Ground under repair also includes French drains, which are trenches filled with rocks or stones and newly trenched areas, including grass-covered cables. See Temporary Power Lines and Cables.
- B. Ground under repair may include areas of unusual damage, including areas where spectators or other traffic has combined with wet conditions to affect materially the ground surface, but only when so declared by an authorized member of the Committee. When immediately adjacent to an obstruction, such an area is part of the obstruction.
- 4. <u>IMMOVABLE OBSTRUCTIONS</u>: Include plastic bumpers on roads and paths, and mats secured to the ground with spikes when the bumpers or mats cover cables.
- 5. <u>IMMOVABLE OBSTRUCTIONS CLOSE TO PUTTING GREENS</u>: Model Local Rule F-5.1 as prescribed in Section 8 of the Committee Procedures is in effect.
- 6. <u>RELIEF FROM SEAMS OF CUT TURF</u>: Model Local Rule F-7 as prescribed in Section 8 of the Committee Procedures is in effect. If a player's ball lies in or touches a seam of cut turf or a seam interferes with the player's area of intended swing: (a) Ball in the General Area. The player may take relief under Rule 16.1b. (b) Ball on Putting Green. The player may take relief under Rule 16.1d. But interference does not exist if the seam only interferes with the player's stance.
- 7. <u>WHITE-LINED AREAS TYING INTO ARTIFICIALLY SURFACED ROADS AND PATHS</u>: White-lined areas of ground under repair and the artificially surfaced roads, paths or other identified obstructions that they are connected to are a single abnormal course condition when taking relief under Rule 16.1.
- 8. WOOD CHIPS AND MULCH: Are loose impediments.
- 9. <u>INTEGRAL OBJECTS</u>: Include objects, such as cables, rods, wires or wrappings, when closely attached to trees and boundary objects, and artificial walls and pilings when located in penalty areas or in or adjacent to bunkers, and bunker liners. An exposed bunker liner may be treated as ground under repair, but interference does not exist if the liner interferes only with the player's stance.
- 10. <u>BALL DEFLECTED BY POWER LINE</u>: Model Local Rule E-11 as prescribed in Section 8 of the Committee Procedures is in effect. If it is known or virtually certain that a player's ball hit a permanent power line, tower, or a wire or pole supporting a power line during the play of a hole, the player must replay the stroke by playing the original ball or another ball from the spot where that stroke was made (see Rule 14.6).
- 11. <u>TEMPORARY POWER LINES AND CABLES</u>: Model Local Rule F-22 as prescribed in Section 8 of the Committee Procedures is in effect.
- 12. <u>TEMPORARY IMMOVABLE OBSTRUCTIONS</u>: Model Local Rule F-23 as prescribed in Section 8 of the Committee Procedures is in effect.
- 13. <u>LIST OF CONFORMING DRIVER HEADS</u>: Model Local Rule G-1 as prescribed in Section 8 of the Committee Procedures is in effect.

- 14. <u>LIST OF CONFORMING GOLF BALLS</u>: Model Local Rule G-3 as prescribed in Section 8 of the Committee Procedures is in effect.
- **15.** <u>**TRANSPORTATION**</u>: Model Local Rule G-6 as prescribed in Section 8 of the Committee Procedures is in effect. During the round, a player must not ride on any form of motorized transportation except as authorized or later approved by the Committee (a player may always ride to and from where a previous stroke was made).
- 16. <u>PROHIBITING USE OF CERTAIN TYPES OF SHOES</u>: Model Local Rule G-7as prescribed in Section 8 of the Committee Procedures is in effect.
- 17. <u>PROHIBITING USE OF AUDIO AND VIDEO DEVICES</u>: Model Local Rule G-8 as prescribed in Section 8 of the Committee Procedures is in effect. Rule 4.3a (4) is modified in this way: During a round, a player must not listen to or watch content of any nature on a personal audio or video device.
- 18. <u>USE OF CADDIE PROHIBITED</u>: Model Local Rule H-1.1 as prescribed in Section 8 of the Committee Procedures is in effect. A player must not have a caddie during the round.
- 19. <u>RESTRICTIONS ON PRACTICE BEFORE OR BETWEEN ROUNDS</u>: Model Local Rule I-1.1 as prescribed in Section 8 of the Committee Procedures is in effect. Rule 5.2b is modified in this way: a player must not practice on the competition course before or between rounds. Penalty for breach of Local Rule, see Rule 5.2
- 20. <u>RESTRICTION ON PRACTICE OR TESTING BETWEEN THE PLAY OF TWO HOLES</u>: Model Local Rule I-2 as prescribed in Section 8 of the Committee Procedures is in effect. A player must not make any practice stroke on or near the putting green of the hole just completed or test the surface of that putting green by rubbing the putting green or rolling a ball or make any practice stroke on or near any practice green.

21. STOPPING AND RESUMING PLAY:

- A. A suspension of play for a dangerous situation will be signaled by one prolonged note of a siren or horn. All other suspensions will be signaled by three consecutive notes of a siren or horn. In either case, resumption of play will be signaled by two short notes of a siren or horn. See Rule 5.7b. Note: All practice areas are closed during an immediate suspension for a dangerous situation until the Committee has declared them open. Players who practice on closed practice areas will be asked to stop practicing; failure to stop practicing might result in disqualification.
- B. When play is suspended by the Committee, if the players in a match or group are between the play of two holes, they must not resume play until the Committee has ordered a resumption of play. If they have started play of a hole, they may discontinue play immediately or continue play of the hole, provided they do so without delay. If the players choose to continue play of the hole, they are permitted to discontinue play before completing it. Before lifting the ball, the player must mark its position. The players must resume play when the Committee has ordered a resumption of play. Resumptions of play will be signaled by two short notes of a siren or horn.
- 22. <u>DRESS CODE</u>: Players must adhere to the dress codes set out by each hosting course.
- 23. <u>ADVICE:</u> Each team may appoint one person who may give advice to members of that team. Advice givers must be identified to the Committee before giving advice. Advice may only be given to a player between the play of two holes or during suspensions of play but may not be given while a player is playing a hole. The penalty for each breach of this Rule by an advice giver is the General Penalty added to the player's score who is involved.
- 24. <u>SCORING AREAS AND PROCEDURES</u>: Details on scorecard return procedures and scoring areas will be provided on the Notice to Players at each event.
- 25. MODIFICATION OF PENALTY UNDER RULE 3.3b(2) FOR MISSING PLAYER OR MARKER CERTIFICATION: Model Local Rule L-1 as prescribed in Section 8 of the Committee Procedures is in effect.
- 26. <u>WHEN COMPETITION IS FINAL</u>: The competition is final when the trophy has been presented to the winner or, in the absence of a prize ceremony, when all scores have been approved by the Committee.
- 27. <u>UNSPORTSMANLIKE BEHAVIOR</u>: A player may be disqualified without warning for unsportsmanlike conduct such as throwing a club, disrespectfully addressing or striking another player or official, using profanity or obscene gestures, intentionally obstructing another player's line of play, etc.
 - A. Any disqualification for unsportsmanlike conduct disqualifies the player for the entire championship. Substitution of a player disqualified for unsportsmanlike conduct is not permitted.
 - B. Disqualification for a violation of USGA rules applies to that day's competition only.

<u>Rules</u> USGA and OSAA Rulesof Golf will govem al play except as modified by the Local Rules sheet.

Coaching Each school may appoint one person to give advice to its participants each day provided that the advice chey tee off on the next hole and the advice is given in a private manner and does not unduly delay play. not be given during the playing of a hole but rather from the time a participant holes out on a hole until

Spectators

Spectators must stay oncart paths or in the rough and at least 30 yards from any competitor during play. At no time should a spectator be on the green, on the tee, in a faitway, in a bunker, in a hazard, nor should giving advice, which could influence a player indetermining play, the choice of a club or method of making they stand behind a player during a swing. Spectators may not communicate with participants from the time a player begins the round until the scorecard is handed in. Competitors may be penalized and/or disqualified if any person, other than the designated coach, assists the competitor by coaching and/or a stroke.
