SUBJECT: Update on the Proceedings of the Classification and Districting Committee

The Classification and Districting Committee for the 2026-30 four-year time block held its sixth and final public meeting at the OSAA Office in Wilsonville on December 1, 2025, to receive testimony and review written correspondence thus far received.

After Committee introductions, the group received a brief review of the timeline and an explanation of the meeting and testimony procedure. The reviews were conducted by OSAA Executive Director Peter Weber and Committee Chair Iton Udosenata, Superintendent of Tigard-Tualatin School District.

The Committee received testimony from twelve people in person and eight online. Testimony and/or written correspondence have come from each classification. The Committee has received more than 210 pieces of correspondence to date. The Committee then adjourned to a closed work session to discuss the testimony, plus written correspondence received in advance of the meeting, to determine its final recommendations.

The release of the Committee's Final Recommendation is not the final step in the public process. Member schools and the public will also have the opportunity to respond to the Committee's Final Recommendation to the Executive Board in writing prior to and/or in person at the public meeting at which the Board will act on the Final Recommendation on December 15, 2025, at the Holiday Inn, Wilsonville. The Board will meet at 9am to consider member school written input and public testimony prior to acting on the Committee's Final Recommendation, and the Delegate Assembly will subsequently meet at 1pm to act on cutoff points and number of leagues for the new time block.

Following the closed work session, the Committee reached consensus on the following issues:

Number of Classifications: The Committee is recommending a six-classification model.

Petitions to Play Up: The Committee recognizes the desires of some schools to play at a higher classification than their enrollment number may place them. Confirmed Play Up requests were received during the process from these schools:

Petitions to Play Down: The Committee recognizes and supports the Petition to Play Down requests approved by the OSAA Executive Board for schools that met the established criteria. Approved Petitions to Play Down include:

Final Recommendation Classification Breakdown

1A: Upper end cutoff was adjusted back down to 65. The Committee reviewed the share out from the October Delegate Assembly meeting that indicated support for dropping the number to 65 to reduce the overall number of schools at the 1A

classification. Removed Crane and Harper Charter from the High Desert League and Elgin from the Old Oregon League based on the cutoff change.

2A: Lower end cutoff was adjusted back down to 66. Split out the nine-school Wapiti League into two separate six-team leagues, Wapiti League and Blue Mountain Conference. Added Crane, Elgin, and Harper Charter to the Wapiti League per the cutoff change.

3A: No change to cutoffs. Renamed 3A-1 to the Coastal Range League and 3A-2 to the Lewis & Clark League per school requests. Moved Corbett from 3A-2 to 3A-1 based on a school request and incoming league support.

4A: Upper end cutoff changed from 580 to 560 to better address ratio of largest to smallest schools in the classification and improve competitive balance in the classification. The Committee spent time discussing a change in the lower end cutoff but ultimately determined the overall impact on the 3A, 4A, and 5A classifications would be too significant. Removed Cascade from the Oregon West Conference and Henley from the Skyline Conference per the cutoff change.

5A: Lower end cutoff adjusted to 561 to better address ratio of largest to smallest schools in the classification. Added Cascade to the Mid-Willamette Conference per the cutoff change. Added Henley to the 5A-5 Southern Cascade Conference with Ashland, Crater, and Eagle Point. Dissolved the Southwest Hybrid.

6A: Created the 6A-7 Southern Oregon Conference with Grants Pass, North Medford, Roseburg, and South Medford. Dissolved the Southwest Hybrid.

Additional Committee Recommendations: The Classification and Districting Committee has two additional recommendations for the Executive Board after having been through this process:

1. Reconvene the Computation of ADM Task Force next school year to explore potential changes to how ADM is calculated when classifying schools. The Committee received testimony and written correspondence related to considering the following additional criteria: school participation figures, adjusting/eliminating any socioeconomic factor, moving private schools to higher classifications, going back to counting all 9-12 students, considering the impact of transfers, incorporating a success/lack of success factor, and examining the impact of any such changes specifically as it relates to smaller schools.
2. Review current established deadlines for Petition to Play Up and Petition to Play Down requests to make sure they align appropriately with the timeline of the committee process.

OSAA Staff previously confirmed, based on conversations with the OSAA Executive Board, that the OSAA Football Ad Hoc Committee is again charged with reviewing and providing recommendations related to football classifications, districts, and structure during the new time block. The OSAA Football Ad Hoc has met once for an organizational meeting and its first public meeting will be Thursday, December 4 at 10am at the OSAA Office in Wilsonville. They will have multiple public meetings in December and January to solidify their recommendations to be forwarded to the OSAA Executive Board for review and consideration at their February 2, 2026 meeting.
