SUBJECT:	OSAA Officials Fee Review Committee – June 4 Meeting update

The Officials Fee Review Committee conducted their second public meeting on June 4, 2018 at the OSAA Office in Wilsonville. The constitutionally mandated purpose of this Committee is to make recommendations to the OSAA Delegate Assembly for adoption in October 2018. These recommendations will consider only items involving fees paid to individual officials, commissioners, or Local Associations. This includes game fees, mileage, per diem, check writing fees, commissioner fees, or any other type of service fee provided.

The Committee receive one public testimony then adjourned to a work session to begin development of a recommendation.

The Committee discussed several topics and came to some consensus on several items: The following items were accepted, but still open for discussion:

- A 3-year fee schedule that maintains the current structure with an average 2.5% increase each year starting in 2019-20 and ending in 2021-22.
 This would be an increase to a 6A/5A/4A school on average of \$721 a year and 3- year total \$2,185.
 This would be an increase to a 3A/2A/1A school on average of \$360 a year and 3-year of \$1,100.
- The 3A/2A/1A Varsity rate would continue at 90% of the 6A/5A/4A Varsity rate for the 2019 2020 school year, increase; 95% of the 6A/5A/4A Varsity rate for the 2020 2021 school year; and 100% of the 6A/5A/4A Varsity rate for the 2021 2022 school year. All sub-varsity would be 75% of the Varsity rate each respective classification level. This will be an increase to a 3A/2A/1A school on average of \$890 and 3-year increase of \$2700.
- Maintaining the current pay rate differentials between various sports.
- Increase the per-official game fee amount for 3-person basketball crews from 85% of the 2-person rate to 100% of the 2-person rate effective in the 2019-2020 school year, the first year of the new fee schedule.
- Revising the game fee cancellation policy for sports other than baseball and softball to include situations currently not covered and adding several interpretive scenarios to clarify the policy. OSAA staff will develop the interpretive scenarios
- Adding a late payment fee to the schedule. Member schools would have 30 days from invoice date or from first contest date, whichever is later, to pay the invoice in full or a 10% late fee would be applied.
- There was some discussion on increasing the Commissioner's fees for Baseball and Softball because of the massive amount of work involved in scheduling and rescheduling games due to weather. The Committee tabled this asking for more input from both the Commissioners of those sports and from the schools.
- The was lots of discussion on adding an "excessive" change fee to the schools, but the Committee needs more information on what would be considered "excessive" and what would be a fair fee to charge for this.
