SUBJECT:	OSAA State Championship Committee – December 11 Meeting Update

The State Championship Committee for the 2018-2022 four-year time block held its fifth public meeting at the OSAA office in Wilsonville on December 11, 2017. The constitutionally mandated purpose of this Committee is to make recommendations to the OSAA Executive Board for adoption in February 2018, regarding championship formats, participation policies and issues relative to the administration of OSAA State Championships.

The Committee received testimony from 17 individuals addressing specific areas of state championship structures in the activities of baseball, cheerleading, cross country, track and field, and wrestling. While they considered each proposal, and had extensive discussion in relations to them, some were not supported for various reasons (format, cost to association, cost to schools, feasibility, etc.).

The Committee discussed and is currently supportive of these items:

- Playoff Reimbursement Formula
 - 1. Adding three additional levels of reimbursement which will be at the mileage levels of 801-900, 901-1000, 1000 and above.
 - 2. Eliminating per diem reimbursement for roundtrip mileage of 151-200.
- The Committee will continue to examine the impact of the OACA proposal, requesting 2 additional players be allowed in soccer and volleyball.
- Continuation of the better ranked team hosting and not going to neutral sites in the semifinal rounds of soccer, baseball and softball.
- Looking more closely at the impact on the Association and schools if non-local officials were used for baseball and softball beginning in the semifinals.
- Basketball Final Site Formats at all Classification Levels Committee unanimously supports schedule changes that will place same gender in the same session at all final sites, as is currently formatted at the 6A championship.

The Committee welcomes all written proposals regarding any State Championship related subjects. Those submitting proposals need to provide data that would illustrate support from various groups including but not limited to superintendents, principals, athletic directors and coaches. All public testimony should be concise and correspond to the information being presented.

Any communication from school representatives regarding Committee issues should be sent to the OSAA rather than to individual Committee members. All written communication received by the OSAA will be shared with every Committee member for review and discussion. Please send emails for the Committee to <u>krisw@osaa.org</u>.

The next public meeting of the State Championship Committee will take place on Monday, January 8, 2018, at the OSAA office in Wilsonville. The Committee meeting will begin with an opportunity for public testimony at 9 am. There will be an opportunity to watch this meeting and communicate via the webinar at AnyMeeting, with the link being published in the weekly broadcast.

MUSIC
The Committee supports the following number of qualifiers for music state championships. These recommendations bring the percentage of qualifiers of competitive groups in line with percentages in other OSAA state championship events and better reflect current participation levels at each classification.

Speech
The Committee supports no changes at this time. They have reviewed 3 proposals from OHSSLCA and are waiting for more information on the financial impact of additional participants.

Cheerleading
The Committee has requested OSAA staff look into the financial impact of moving to a prelims and finals format in divisions with high participation, as long as the championship remains a one-day event. The OCCA requested a venue review, with thoughts of saving funds to offset the cost of the additional time needed if prelims are added.

Dance / Drill
The Committee supports the change presented by the Dance/Drill Coaches Association Board of Directors to move the state championship to a category state championship starting in 2019. The Category State Championship would consist of four categories (Jazz, Contemporary/Modern, Precision, Prop/Show). This proposed change would modify the event from a three-day to a two-day event.

	BASEBALL - The Committee received testimony from school representatives requesting that the group consider implementation of a double elimination bracket. After review, the Committee does not support the proposal because of the challenges it brings in relations to neutral site locations and the number of facilities needed, no home crowd or event management when neutral sites are used, travel involved for all teams to neutral sites, weather, as well as various other factors. Additionally, the use of a double elimination bracket is not used in any other OSAA team sport championship. The Committee understands the concern with pitching limitations and will continue to review the post-season schedule to see if this can be addressed in other ways.

	 The Committee received testimony from school representatives requesting that the group consider implementing a process that forms a group that would select "at-large" teams that would be added to qualifying fields. Classifications appear to prefer designated allocations for each league/special district and if those allocations do not meet the desired number of qualifying teams the group would then select the remaining qualifying teams using a defined criterion. The Committee has requested that those schools supporting the idea of using criteria to identify qualifying teams provide more specific information on who would serve on this type of selection group, what criteria would be used, and the timelines involved prior to making any final decision on whether to support this concept.
6A	Top 2 teams in each league meet plus + 6 highest placing individuals not members of qualifying teams. The Committee is exploring potential "at-large" process that would qualify additional teams. 	Wrestling
	The Committee received testimony from school representatives requesting that the group consider implementing a process that forms a group that would select "at-large" individuals that would be added to qualifying fields. Testimony indicated that classifications do not support rotating qualifying spots and would rather use a process that "pools" potential qualifiers and after applying a defined criterion would identify those additional wrestlers needed to fill the allocated qualifying spots. The Committee has also requested OSAA staff provide some additional data on participation at Special District meets over the last four years. There is concern that adjustments in school classifications may have impacted overall anticipated participation numbers at the various classification levels and as such will have a potential negative impact on qualifying percentages. The goal of the Committee is to equate as much as possible the opportunity to qualify at each level and applying past data to the new classification time block will help the Committee better understand the impact of schools moving up and down.
