Email with registration confirmation and receipt of payment is sent from Arbitersports (messaging@arbitersports.com)



Added to OSAA group of officials and T&F specific sub-group



Online tests and clinics are available (*rules exam/concussion*)



1 to 3 Business Days



Background checks are submitted every work day by noon to initiate the screening (*may take up to 3 days to process*)



Registered badge appears once background check clears (*previous officials may clear faster than new officials*)



3 to 5 Business Days



Officials packet is shipped with a tracking number (*mail batches are processed every 2-3 business days*)



Email confirmation with tracking number is sent once registration has been processed in a mail batch (shipping@osaa.org)



Packet may take 2 to 3 days to be delivered via USPS (*undeliverable packets may be returned to the OSAA office due to incomplete or invalid addresses which will delay packets*)



Email confirmation is sent once free digital rule book and case book are available from the NFHS (allaccess@nfhs.org)

REGISTERING IS STEP ONE – TO BECOME CERTIFIED, OFFICIALS MUST COMPLETE THE FOLLOWING

OFFICIAL TAKES THE ONLINE OSAA RULES EXAM

- Completes the rules exam on ArbiterSports scoring at least 75%



OFFICIAL TAKES THE ONLINE OSAA CONCUSSION COURSE

- Successfully completes the OSAA's "Understanding Concussions – What Officials Need to Know" training course via ArbiterSports
- Annual requirement in compliance with state law
- 10-minute training course designed for officials
- Also available in Spanish



OFFICIAL TAKES THE ONLINE OSAA IPDA TRAINING COURSE

- Successfully completes the OSAA's "Interrupting and Preventing Discriminatory Acts" training course via ArbiterSports
- One-time requirement in compliance with state law
- 20-minute training course

Official is certified for high school track and field competitions



The official's individual **Monitor Eligibility** report will reflect their completed requirements



Next Steps



Once certified, officials can start looking for track meets; there is always a need
